#### Dear Board Members:

Welcome to the Treasury Report along with a 2020 projected budget for approval. The financial profile for IASWG at September 30, 2019 begins with a table of Cash on Hand. Once again, our

financial health holds relatively steady, but you will note that a deficit is projected for 2020. Now, a few notes about this table. ►

First, we had enough COH the last few years to develop a <u>Special-Projects</u> budget for chapter activities to promote membership and scholarships to attend symposia.

Second, now that the Birnbaum gift and Endowment funds from the Anna Fritz estate are combined, it is up to the board to determine whether the Special Projects budget should continue or whether special projects should come

from the annuity interest earned (a few thousand dollars) each year.

As noted in the last report the TD checking account line includes a generous <u>\$25K gift from Martin</u> <u>Birnbaum</u>, founding IASWG member, as well as <u>a generous bequest from the Anna Fritz Estate</u> (<u>\$78,571.52</u> earmarked for the IASWG John and Carol Ramey Endowment Fund. Money originally earned for Endowment is invested with the <u>New York Life Insurance Company in an annuity</u> (<u>\$246,059.42</u>), earning about \$5K per year, which we use for operating expenses. The development of a second annuity instrument is in process at the time of this writing.

COH beyond endowment is used for varied expenses (often unexpected, e.g., upgrading technology). Whether interest from our second annuity investment of \$104,000 is allocated to the same ends or another, such as special chapter activities or scholarships or any other source, is TBD by the board.

After the expenses table please note the Special Projects report for 2019 and a suggested budget for 2020. <u>The 2019 Final Special-Project Budget and the 2020 Special-Project budgets require approval</u>.

The next pages provide a breakdown for 2019 through 9/30 and projections for 2020. After the page on Special Projects there is a final report with financial tally for the IASWG 2019 Symposium and a proposed budget for the IASWG 2020 Symposium. <u>Both the 2019 Final Symposium Budget and 2020</u> <u>Proposed Symposium Budget require approval</u>. At the end of this report is the travel-reimbursement request form. Please submit it by November 30.

#### NARRATIVE NOTES

<u>Endowments</u>: Increases in the John and Carol Ramey Endowment Fund over the years reflect both contributions and earned interest. Capital is not permitted for routine operations, but because the interest is, and so is routinely allocated to general expenses. The John and Carol Ramey Endowment Fund was initiated in the late 1990's and raised \$200K+ over a few targeted years. We continue to invite contributions. The other portion of the Fritz Estate bequest to the IASWG, Inc. John and Carol Ramey Endowment Fund is currently in the possession of the Northeast Ohio chapter; disposition TBD.

1) By the time you read this report, we may well have moved some of this money (\$104K) to our second New York Life annuity, approved at the last board meeting. At the time of writing, however, that transaction was still in process. That transaction will be reflected on the next report.

2) That the officers of the Northeast Ohio are in possession of this money is an exception to the norm of chapters' being the recipients of \$200 annual rebates in order to hold chapter-based events. Thus, normally, chapters receive \$200 per year and spend \$200 such that there is no legal need to report their bank holdings to the IRS for tax purposes. This amount, however, reflects a portion of the Anna Fritz Estate bequest to the Ramey Endowment Fund, and its legal status along with implications of being held separately from the John & Carol Ramey Endowment Fund housed in our two annuity instruments is being addressed by the NEO representatives and parent organization (IASWG).

## IASWG SPECIAL PROJECTS INITIATIVES

## **REPORT: SPECIAL PROJECTS 2019**

<u>Background</u>. In November 2017, \$9K was allocated by the Board for spending beyond routine budget items. Of that amount \$4K was allocated for chapters activities that aim to promote mission and membership; \$5K was targeted for chapters support to members for travel to the symposium in South Africa. Of the \$5K allocated to symposium scholarships, \$3K was allocated for 10 international scholarships @ \$300 each, conceptualized as a matching grant of \$300 to any IASWG chapter (one per chapter except SA) resulting in a total possible \$600 subsidy to a chapter member for attending the SA symposium. The remaining \$2K was offered to South African chapter to provide 10 \$200 national scholarships to the symposium.

At 10/31/18, 2018 funds from this Special Budget were used as follows: The IASWG chapter in Lithuania requested and received \$500 toward the Lithuanian camp (October, 2018) expenses.
